Methodology

- Public Opinion Strategies conducted a national telephone survey of actual voters on election day to measure 2022 voters' views on key issues.
- The survey was conducted on November 8, 2022.
- The survey was conducted among N=800 actual voters.
- The margin of error for a survey of N=800 is $\pm 3.46\%$.



Support for Third Party Litigation Funding Disclosure


Voters support disclosure of third party litigation funders that have invested in a lawsuit and stand to receive a portion of any settlement or award.

Support for Disclosure Crosses Party Lines

Large majorities of Republicans, Independents, and Democrats support requiring disclosure of third party litigation funders.




Voters Oppose Allowing Foreign Govts. to Invest in U.S. Litigation
